Average Daily Population in DOC Institutions

The average number of Virginia state responsible offenders incarcerated in DOC institutions in June 2020 was 27,239. This is a 2.07% decrease from the 27,816 average Virginia inmate population in custody last month and a 9.02% decrease from the average population (29,938) reported one year ago. In June 2020, the average number of out of state offenders housed in contract beds was 55. The total average institutional daily population (ADP) in DOC institutions was 27,294 offenders.

The end of month Probation & Parole caseload for June 2020 was 68,630. This is a 0.12% decrease from the 68,714 reported for last month and a 3.02% increase from the 66,615 offenders reported one year ago.
